- CLASS #2 - 8-10 jumps, maximum 2'0" in height.
- CLASS #3 - 8-10 jumps, maximum 2'3" in height.
- CLASS #4 - 8-10 jumps, maximum 2'6" in height.
- CLASS #5 - 8-10 jumps, maximum 2'9" in height.
- CLASS #6 - 8-10 jumps, maximum 3'0" in height.
- CLASS #7 - 10-12 jumps, maximum 3'3" in height.
- CLASS #8 - 10-12 jumps, maximum 3'6" in height.

All classes: Table II. Time taken first jump off over shortened course immediately following clear round.
Re-do rounds (no jump off) \$10.00, but only original round to count toward ribbon.

Jumper Series Championship: Horse/rider combination 1st – 6th placings in each show will count toward end of season awards. No limit to classes entered, but only top 3 scores per entry per show will count toward Championship.

PRACTICE FENCES MAY BE JUMPED IN ONE DIRECTION ONLY - red marker on right, white marker on left.
Helmet required & safety vest encouraged whenever mounted.
